HB 41 - Incumbent Worker Training Program Updates



The Incumbent Worker Training Program (IWT) awards grants to Montana small businesses to help pay for worker training up to \$2,000 per employee. The training must increase the worker's skill-level, result in a wage gain, or expand business revenue. **Over the last five years, 640 businesses have received grants totaling \$1.5 million, training over 2,000 employees.**

HB41 would increase the per-worker grant amount from \$2,000 to \$3,000 and expand the program to Montana employers of all sizes with the intent of fully exhausting allocated funds. IWT appropriation is \$540,000 of Employment Security Account funds per year, but this funding has not been fully utilized, as shown in the chart below.



Recipients have been in many different industries, with the top industries shown below.


Figure 2. Share of IWT Grant Funded Awarded, SFY18 -SFY22

IWT is currently limited to employers with 50 or less employees, which includes most Montana businesses. HB41 expands eligibility to all Montana businesses, including the 2% of employers with over 50 employees.
