Rulemaking Actions

AMEND

The rule proposed to be amended is as follows, stricken matter interlined, new matter underlined:

24.351.105 ADOPTION OF STATE WEIGHTS AND MEASURES STANDARDS AND RECOMMENDATIONS

- (1) Subject to the provisions of Title 32, chapter 12, part 2, and Title 82, chapter 15, part 1, MCA, the bureau adopts and incorporates by reference the following publications for weights and measures in Montana:
 - (a) NIST Handbook 44, 2023 edition: Specifications, Tolerances, and Other Technical Requirements for Weighing and Measuring Devices with the following modifications:
 - (i) Delete paragraph UR.3.3. Single-Draft Weighing found in section 2.20, Scales.
 - (ii) Delete paragraph UR.2.2. Ticket Printer, Customer Ticket found in section 3.31, Vehicle-Tank Meters.
 - (b) NIST Handbook 130, 2023 edition: Uniform Laws and Regulations in the Areas of Legal Metrology and Fuel Quality with the following modifications:
 - (i) <u>Delete in its entirety III, Uniform Laws part B, Uniform Weighmaster</u> Law.

- (i)(ii) IV Uniform Regulations part A, Uniform Packaging and Labeling Regulation section 14, insert in the blank space January 1, 2024, for the effective date.
- (iii)(iii)IV Uniform Regulations part B, Uniform Regulation for the Method of Sale of Commodities, section 5 insert in the blank space January 1, 2024, for the effective date.
- (iv) <u>Delete in its entirety IV Uniform Regulations part C, Uniform Unit Pricing Regulation.</u>
- (iii)(v) IV Uniform Regulations part D, Uniform Regulation for the Voluntary Registration of Servicepersons and Service Agencies for Commercial Weighing and Measuring Devices, section 3, Registration Fee, insert in all blank spaces, \$25.00. Section 8 insert P.O. Box 200516 Helena Mt 59620 in the blank space.
- (iv)(vi) IV Uniform Regulations part E. Uniform Regulation for National Type Evaluation, section 4(c) through (g) insert in all blank spaces January 1, 2024, for the effective date.
- (v)(vii) IV Uniform Regulations part E. Uniform Regulation for National Type Evaluation, section 7, insert in the blank space January 1, 2024, for the effective date.
- (viii) IV Uniform Regulations part F, Uniform Fuels and Automotive Lubricants
 Regulation, section 2.1.2. Gasoline-Ethanol Blends. (a), is deleted and
 replaced with the following subsection: "(a) The maximum vapor
 pressure shall not exceed the latest version of ASTM D4814, 'Standard
 Specification for Automotive Spark-Ignition Engine Fuel,' limits by more
 than 1.0 psi year-round for gasoline-ethanol blends above 1%."
- (c) NIST Handbook 130, 2023 edition: Uniform Laws and Regulations in the Areas of Legal Metrology and Fuel Quality with the following modifications:
 - (i) Delete in its entirety Section III, part B Uniform Weighmaster Law.
 - (ii) Delete in its entirety Section IV, part C Uniform Unit Pricing Regulation.
- (d)(c) NIST Handbook 133, 2022 edition: Checking the Net Contents of Packaged Goods.

Reasonable Necessity Statement

The proposed amendments to (1)(b) and the repeal of (1)(c) are necessary to condense the adoption of and amendments to the NIST Handbook 130, 2023 edition, into one subsection. Formatting the rule to include all the amendments to the NIST Handbook 130 under one subsection conforms with rule-writing standards, and the amendments help to clarify and simplify the rule.

The proposed amendment in (1)(b)(viii) adopting the one-pound waiver is necessary because gasoline-ethanol blends are regularly sold in Montana and other "high altitude states." The proposed amendment restores the one-pound waiver contained in the NIST 130 Handbook, 2012 edition, that was effective until the department adopted the 2023 edition in ARM 24.351.105, 2023 Montana Administrative Register, page 1871, effective January 1, 2024.

Small Business Impact

Pursuant to 2-4-111(1), MCA, the small businesses that will probably be affected by the proposed rule change are small gas stations and other fuel suppliers in Montana that sell and distribute gasoline-ethanol blends. Although this rule change will likely have a positive effect on small businesses by allowing a 1.0 psi variation of vapor pressure for the gasoline-ethanol blends year-round, the agency has determined that the proposed rule change will not create a significant and direct impact on these small businesses.

Bill Sponsor Notification

The bill sponsor contact requirements of 2-4-302, MCA, do not apply.
